TOWN CLERK NOTE: Section 109A of Chapter 54 of the General Laws requires 3% of all of the precincts in Massachusetts must be hand counted as part of the audit process. The Town of Barre's Precinct #1 was selected for this audit. The audit took place in the Senior Center, 557 South Barre Rd on Sunday, November 8th, 2020 from 1:00 p.m. to 6:00 p.m. (not all offices on the ballot were chosen for the audit). Audit Results for Precinct 1 are the final results. Furthermore, In accordance with the provisions of section 6(h)(3) of Chapter 115 of the Acts of 2020, ballots returned by mail that were received up to 5pm on November 6th and postmarked by November 3rd were counted on November 7th at the Henry Woods Building located at 40 West Street, Barre. There were no Federal Write In Ballots Recieved prior to November 13th.
