Pursuant to the foregoing warrant, the inhabitants of the Town of Barre qualified to vote in elections appeared at the Barre Senior Center, 557 South Barre Road, and George L. Thorng American Legion Post 2, 450 South Barre Road, to cast their ballot for candidates and offices of their choice listed below. A total of 1,229 registered voters cast their votes on March 5, 2024 from 7a.m. – 8:00 p.m.
